

Lake Reminders

Now that weather is getting nicer, we wanted to remind you of Lake Policies:

- The East Lake is open from May 1st to October 31st from 1 hour before sunrise to 1 hour after sunset. The West Lake is closed to all watercraft.
- Swimming is not permitted in the Lakes by humans or pets.
- No personal watercraft shall be permitted on the surface of any Lake without first obtaining a Registration Sticker. Users may obtain a Registration Sticker from the Cove during regular operating hours. Users must have a signed Individual and Parent/Legal Guardian Waiver of Liability and Release Form on file.
- Registered Watercraft shall be launched from the dock. Trailered watercraft shall be launched only from beside the dock.
- Motorized vehicles and trailers must remain in authorized areas. Users may not beach watercraft, other than paddleboards, anywhere other than at the dock area.

Watercraft Registration Fees:

- Resident: \$10 per watercraft per year
- Non-resident: \$50 per watercraft per year

May 2023 Regular Election Update

The Districts regular election occurred on May 2, 2023 for the Boards of Directors. In accordance with Colorado election law, the Districts distributed Calls for Nominations in February, asking for interested qualified candidates to run for the open seats on the four Boards. After the deadline for submitting Self Nomination Forms expired, there were no more candidates than there were open seats for any of the Boards. As a result, there was no contested election this year and the candidates who submitted Self Nomination Forms were deemed elected as of Election Day.

There are some new faces on the Board for District No. 2 after Election Day as we welcome Dr. Angelic Inez Cole and Raymond Byrd to the Board. Director, Dallas Becker, was also re-elected to the Board for District No. 2. Directors, Lyndsey Paavilainen, Brandon Curiel, and Brad Wilkin, were elected to the Boards of District Nos. 1, 3, and 4.

The next regular election for the Districts will be in May 2025.

Little Thompson Water District Update

LTWD recently updated their Water Contingency Plan Action Level to WATCH. Under this Action Level there are mandatory watering hours as well as mandatory days for all residential customers.




ER CONTINGENCY R ACTION LEVEL **Current Level** 1st offense - written warning; 2nd offense - \$100; 3rd offense -\$200 4th offense - \$300; If 4th offense fine does not emedy compliance, a \$500 fine will be assessed and flow restrictor installed in the meter Last measure - termination of service at the discretion of the District Manager

Residents who do not follow watering requirements, to include watering days and hours, may be fined in accordance with the number of offenses. The Action Plan Level and Watering requirements associated with Action Plan Levels are set and determined by Little Thompson Water District Board of Directors and are subject to change.

Do you know how many gallons you are allowed per year? The majority of customers within Barefoot Lakes have a Conservation (Urban) Tap which has annual allotment of 114,000 gallons, which is perfect for smaller lawns and gardens, and it helps conserve water while meeting your needs. It is important to note that exceeding your allotment can result in surcharges of up to \$20 per every 1,000 gallons over the allotment. You are able to view your Year to Date (YTD) water usage and Annual Allotment on your monthly statements.
